### Amendments to Business Rules of NSDL – Revision in settlement fee

With effect from June 1, 2019, NSDL has revised the settlement fee in respect of a debit instruction levied to the Participant from ₹ 4.50 to ₹ 5.00 per debit instruction. Accordingly, the Business Rules have been amended and will come into effect from June 1, 2019.

### Increase in timelines for processing of Dematerialisation Requests

Based on representation made by NSDL, SEBI has granted relaxation in timelines for processing of dematerialisation requests to 15 days till June 30, 2019 from the current 7 days as specified in Regulation 74(4) of SEBI (Depositories and Participants) Regulations, 2018.
