Enhancement of BSDA downloads on Local DPM and 'List of Demat Accounts for BSDA' report on i-Assist

In view of the changes in the BSDA eligibility and charges, NSDL has enhanced the monthly report named 'List of Demat Accounts for BSDA' available on i-Assist site to include value of holdings in respect of debt securities and other than debt securities. Changes have also been incorporated in BSDA Evaluation downloads available in Local DPM.

Discontinuation of submitting bid-cum-application form with any intermediary along with bank account details for ASBA

With effect from July 1, 2019, retail individual investors can submit Bid-cum-application form with any intermediary (namely syndicate member or sub - syndicate member or stock broker or depository participant or registrar to an issue and share transfer agent) using his / her UPI ID linked to own account for the purpose of blocking of funds.
