Redemption of Commercial Papers – no transfers after maturity date

As per the Reserve Bank of India (RBI) Commercial Paper Directions, 2017 issued by RBI on August 10, 2017 and Operational guidelines on Commercial Paper issued by Fixed Income Money Market and Derivatives Association of India (FIMMDA) on October 5, 2017, for redemption of commercial paper, investors are no longer required to transfer commercial paper held in their beneficial owner accounts to Issuing and Paying Agent’s (IPA) Redemption account. Commercial Papers have been extinguished directly from the beneficial owner accounts of Investors through corporate action for the purpose of redemption.
