Transfer of securities held in physical mode – clarification

SEBI has clarified the following regarding transfer of securities held in physical mode:

1. Investors may continue to hold the shares in physical form even after April 01, 2019. However, any investor who wants to transfer shares (which are held in physical form) after April 01, 2019 can do so only after the shares are dematerialized.
2. The transfer deed(s) lodged prior to deadline and returned due to deficiency in the document may be re-lodged for transfer even after April 01, 2019.
3. Investors can continue to demat their physical shares, transmission (i.e. transfer of title of shares by way of inheritance / succession) and transposition (i.e. re-arrangement / interchanging of the order of name of shareholders) in physical shares even after April 01, 2019.

Reporting for Artificial Intelligence (AI) and Machine Learning (ML) applications and systems offered and used by market intermediaries

Participants which are offering or using AI and ML applications or systems as defined by SEBI should submit a report in prescribed format to NSDL on quarterly basis within 15 days of the expiry of the quarter.

Internal and Concurrent Audit for depository operations

Participants are required to have its depository operations audited by a qualified Chartered Accountant or a Company Secretary or a Cost and Management Accountant holding a Certificate of Practice and submit the report to NSDL on half yearly basis as mentioned below -

Audit Period	Due date for submission of report to NSDL
April 1 to September 30	November 15
October 1 to March 31	May 15

Audit should cover all facets of the depository operations. Auditor may expand the scope of audit / add more audit points to achieve the objectives.
