2. **Implementation of CAPTCHA on NSDL e-Services facility**

NSDL has implemented CAPTCHA (*Completely Automated Public Turing test to tell Computers and Humans Apart*) on NSDL e-Services facility for enhanced security feature during Client/User authentication. CAPTCHA test is randomly generated sequence comprising of letters and/or numbers that shall appear as a distorted image. User shall enter the displayed characters in the provided text box as User Authentication before login into the e-Services facility.

3. **Facility for submission of reports w.r.t. Surveillance Obligation for Depository Participants through e-PASS.**

NSDL has developed a facility for submission of following reports through online portal - e-PASS (<https://www.epass.nsd.com/>) -

- Quarterly reporting of status of alerts generated by Participants to be provided to NSDL within 15 days from the end of quarter.
- Reporting of Adverse Observation for transactional alerts generated by Participants.

Sharing of transactional alerts by NSDL and reporting of status of the alerts by Participants.

4. **Mandatory update of certain attributes of KYC of clients extended till March 31, 2022**

Last date for mandatory update of 6-KYC attributes namely Name, Address, PAN, Mobile Number, Email ID and Income range in respect of all existing accounts has been extended from December 31, 2021 to March 31, 2022.

Demat account would be frozen in case of non compliance.

5. **Amendment to Business Rules of NSDL - SMS notification fee**

An Issuer shall pay a fee plus applicable taxes for every e-Voting event for sending SMS to Clients as per fee structure given below:

Paid Up capital (₹)	Setup Fee (₹) per event	Transaction Fee (₹)
Up to 5 crore	1000	0.45 per record
Above 5 crore to 10 crore	2500	
Above 10 crore	5000	

Provided that in case of Issuer request to re-send SMS for any particular event, then only Transaction fee as per aforesaid structure will be levied and no setup Fee will be levied again.

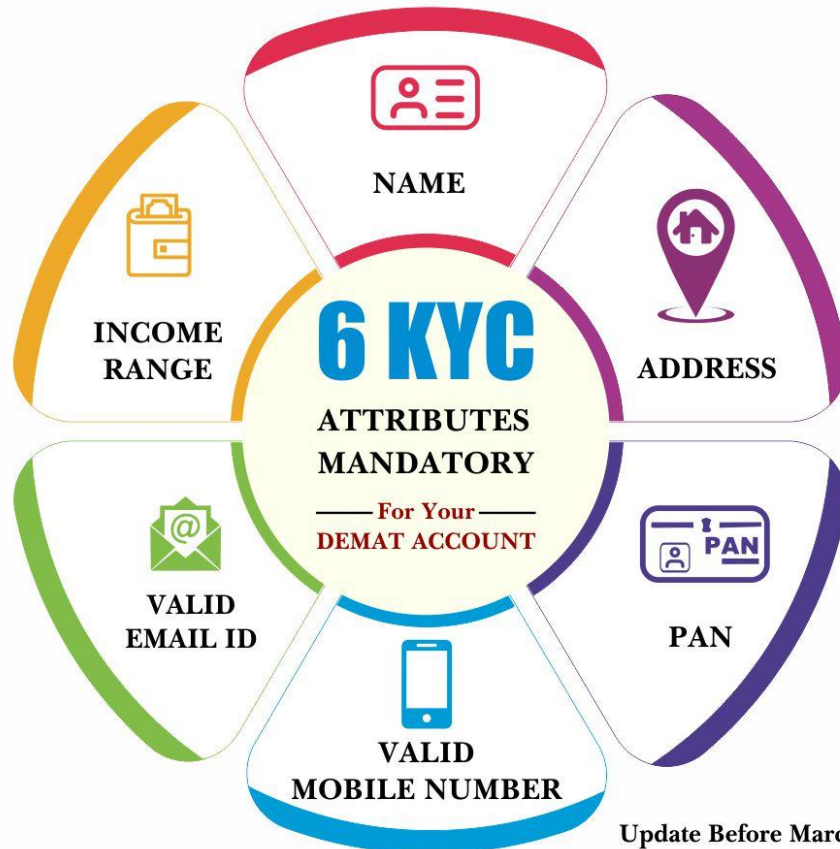
