### Update in format of Internal and Concurrent Audit Report

Participants are aware that as per Bye Law 10.3, each Participant is required to have its depository operations audited by a qualified Chartered Accountant or a Company Secretary or a Cost and Management Accountant holding a Certificate of Practice. Based on such audit, a copy of the report should be submitted to NSDL on half yearly basis. The audit report format has been modified and same is applicable for audit period April 1, 2018 to September 30, 2018 onwards.

### Streamlining the process of public issue under the SEBI Regulations

In order to make the existing process of issuance of debt securities easier, simpler and cost effective for both issuers and investors, SEBI has reduced the time taken for listing after the closure of the issue to 6 working days (from present requirement of 12 working days). This shall be applicable for all public issues of debt securities, Non-Convertible Redeemable Preference Shares and Securitised Debt Instruments opening on or after October 01, 2018.

### SEBI's clarification regarding notification dated June 8, 2018 mandating transfer of securities in dematerialised form

SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 was amended vide notification dated June 8, 2018. As per amended regulations, transfer of shares in physical form would not be processed unless the securities are held in the dematerialized form with a depository from December 5, 2018. SEBI vide its Press Release no. 34/2018 dated August 10, 2018 has clarified the following:

1. The amendment does not prohibit the investor from holding the shares in physical form, investor has the option of holding shares in physical form even after December 5, 2018.
2. The amendment is not applicable for transmission (*i.e. transfer of title of shares by way of inheritance / succession*) and transposition (*i.e. re-arrangement / interchanging of the order of name of shareholders*) cases.
3. Any investor who is desirous of transferring shares (which are held in physical form) after December 5, 2018 can do so only after the shares are dematerialized.

- a. A duly certified Client Master Report printed either from the DPM or back-office system; or
- b. A covering letter generated from the DPM or back-office system which incorporates the aforesaid details.

**Opening of depository account in joint names with an individual and a body corporate**

Participants can facilitate opening of depository account for the nominee shareholders as a joint account between an individual and body corporate, as desired by the clients. In case the first holder is an individual, the account needs to be opened in individual category whereas, if the first holder is a body corporate then the account type will be “Body Corporate”. Participants are required to obtain KYC information and other required documents for all joint holders as applicable. Further, since a body corporate would be a joint holder, nomination facility cannot be availed in these cases.
