From the Managing Director & CEO's Desk

Dear Reader,

NSDL has completed 12 years of operations on November 7, 2008. We all know about the Global turmoil and its effect in India. Last six months have seen some unprecedented decline in Indian Capital Markets. This has impacted the overall volumes in the market and in turn the volume of the depository activity. Till October 31, 2008, 27,189 crore securities worth more than Rs. 29,57,100 crore (more than USD 600 billion) have been dematerialised with NSDL. The fall in markets has resulted in the value of securities in NSDL system coming down. More than 7,700 companies have joined NSDL and 266 Participants service more than 95 lakh investor accounts through more than 8,100 locations across about 900 cities/towns in the country. Today, equity markets settle almost 100% of its volumes in the dematerialised form.

Consequent to the appointment of Mr. C.B. Bhawe as Chairman, SEBI by the Government of India, Mr. Bhawe tendered his resignation from the position of Chairman and Managing Director (CMD) of NSDL with effect from February 18, 2008. Mr. Bhawe was associated with NSDL as its Managing Director since inception. During his tenure, Mr. Bhawe made valuable contribution to the depository system as well as in the area of direct tax reform by successfully implementing Tax Information Network (TIN) project which has brought immense transparency in the direct tax administration system in the country.

Recognising the competency of NSDL in the management of large databases, Pension Fund Regulatory and Development Authority (PFRDA) has appointed NSDL as Central Recordkeeping Agency (CRA) under the New Pension System (NPS) in India. Honourable Union Finance Minister, Shri P. Chidambaram launched this system in August 2008. Details of CRA project are given under NSDL initiatives in this issue.

In line with NSDL's continued commitment to deliver cost effective services and its policy to reduce charges with the growth in volumes and share the benefit of increased volumes with the users of Depository system, NSDL reduced the settlement fee charged to the Participants from Rs. 6 to Rs. 5 (i.e. a reduction of 16%) per debit instruction from January 1, 2008.

Our internet based initiatives viz.; **SPEED-e** and **IDeAS** are gaining steady popularity and I am sure that with the increase in number of internet users across the country, these initiatives will find many more active users in days to come. Today, 80 Participants are offering **SPEED-e** facility. A list of the Participants offering **SPEED-e** is given in this issue. As investors are aware, **IDeAS**, which is an internet based facility to view transaction statement, has been made mandatory for all Participants. Our initiative of SMS alert facility has already gained popularity. More than 35 lakh account holders have registered for SMS Alert facility so far. Through this facility, investors can receive SMS alerts on their mobile for debits (i.e. transfers) to their demat accounts and for credits in respect of IPO, sub-division and bonus. Alerts are also sent in case the instructions given by investors for debiting their demat accounts fail due to insufficient balance. NSDL offers this facility free of cost which has lots of benefits for investors.

As investors are aware, demat accounts, where PAN details have not been provided, have been frozen or 'Suspended for Debit'. NSDL has directed its Participants to close zero balance accounts, which have not complied with the requirement of PAN, by November 29, 2008. I would like to urge all these account holders to comply with the requirement of PAN to avoid any hassles in future.

In keeping with its practice of reaching out to the investors to get their feedback and understand their problems, NSDL organized 127 investor seminars and interacted with about 13,300 investors across the country during the last year. NSDL has also continued its practice of testing the readiness of its disaster recovery site (DRS). A detailed write-up on NSDL initiatives is given in this issue.

This NEST Update, the 12th anniversary edition, gives details of the progress of NSDL. NSDL holds more than 80% of value of securities held in dematerialised mode in India and it is the largest depository in India. NSDL holds more than 95% of debt

securities that are held in dematerialised mode. In the year 2008, more than 2.2 million new accounts have been opened so far. This growth has taken place despite adverse market conditions during the current year. This progress would not have been possible but for the market acceptance of our services. We are thankful to all those who stood by us and partnered us to reach this far.

I look forward to your continued support and cooperation.

News

Updation of Punjab National Bank account numbers and UTI Bank Limited name to Axis Bank Limited

Punjab National Bank (PNB) has truncated the bank account number from present 16 digits to 15 digits. Similarly, name of UTI Bank Ltd. has been changed to Axis Bank Ltd. NSDL has advised its Participants to carry out necessary charges and communicate to concerned Clients about the changes carried-out in their bank details alongwith the transaction statement.

For new demat accounts opened or change in bank details requested by Clients, Participants are advised to capture the correct 15 digit bank account numbers of PNB or bank name as 'Axis Bank Limited' as the case may be. This has been informed to Participants vide Circular No. NSDL/POLICY/2008/0070 dated October 16, 2008.

Rule pertaining to transmission of securities held by Karta of Hindu Undivided Family (HUF) amended

NSDL Business Rule 12.6.4.1. pertaining to Transmission of Securities held by Karta of Hindu Undivided Family (HUF) in the Depository has been modified. Extracts of the aforementioned rule are as under:

"12.6.4.1 Upon death of the Karta of a Hindu Undivided Family (HUF), the surviving member(s) of the HUF may appoint the eldest surviving member of the HUF as the new Karta of the HUF."

Entire text of the aforementioned Business Rule is available on NSDL website www.nsdl.co.in and the same has been informed to Participants vide Circular No. NSDL/POLICY/2008/0072 dated October 17, 2008.

SEBI's clarification on 'In-person' verification of Beneficial Owner (BO)

It has been decided that 'web-camera' may be used for 'in-person' verification for opening of BO accounts at the branch/franchisee offices of the Participant subject to compliance with other SEBI guidelines/circulars relating to opening of BO accounts including verification of relevant documents. This has been informed to Participants vide Circular No. NSDL/POLICY/2008/0076 dated October 27, 2008.

NCFM oriented training programmes for Participants

NSDL conducts NCFM (NSE's Certification in Financial Markets - NSDL-Depository Operations Module) oriented training programmes for Participants to facilitate them to appear for the NCFM examination. In October 2008, such programmes were conducted in Pune, Bhopal, Ahmedabad, Chennai and Hyderabad which were attended by 129 persons.

Performance Summary

Investors :

As on October 31, 2008, there are 95,61,505 Investor accounts from within the country and abroad. 2,294 clearing member accounts have been opened to facilitate trading and settlement of demat shares in the stock exchanges connected to NSDL. Table 1 shows the growth in investor accounts over a period of three years.

NSDL Initiatives

During the last 12 months (i.e. November 2007 to October 2008), the following initiatives were taken by NSDL with an objective of spreading awareness about the depository system, its benefits and safety features and new facilities introduced, amongst all its users:

Towards Investor Awareness:

- SMS Alert facility** - NSDL launched SMS Alert facility for demat account holders on September 1, 2007. Through this facility, investors can receive SMS alerts on their mobile phones for debits (i.e. transfers) to their demat accounts and for credits in respect of IPO, sub-division and bonus. Alerts are also sent in case the instructions given by investors for debiting their demat accounts fail due to insufficient balance. NSDL offers this facility free of cost which has lots of benefits for investors.

The SMS alert facility is available to the investors provided they have given their mobile numbers to their Participants and made a request for this facility.

- Disclosure of Scrip Specific Information on NSDL website** - In order to disclose information related to various transactions taking place in NSDL depository system and based on the advice of SEBI, NSDL is disseminating scrip specific information on its website. Details of the same are available on NSDL website www.nSDL.co.in.
- Investor Depository Meets (IDMs)** - NSDL interacted with investors throughout the country through a series of 'Investor Depository Meets'. These programs were organised to spread awareness amongst the accountholders and others about the new facilities introduced by NSDL, the safety features and precautions to be taken by accountholders while operating in the depository environment.

During November 1, 2007 to October 31, 2008, NSDL organised IDMs in 127 cities/towns across the country, which were attended by more than 13,300 persons. The zone-wise details of these seminars organised during the period are given below:

- Advertisement Campaign** - NSDL has been conducting nationwide advertisement campaigns since 2001. This year, NSDL conducted such advertisement campaign on the theme of "Be an informed demat accountholder" in March 2008. The campaign spanned across 39 publications (20 leading national dailies and 19 vernacular dailies) in 11 languages with an estimated circulation of about 2.73 crore.
- Awareness Advertisements on Radio** - Apart from the investor awareness programmes mentioned above, NSDL had carried-out investor awareness programmes in January 2008 by way of advertisements on radio (Red FM) in Mumbai, Delhi, Kolkata, Bangalore and Chennai in English and Hindi.
- Investor's Guide** - NSDL publishes an "Investor's guide to the Depository System" for promoting investor's understanding of the system. This guide attempts to answer frequently asked questions raised by the investors in relation to depository operations. Apart from English and Hindi, this guide is also available in some other regional languages. Investors may obtain a copy of this publication free of cost from NSDL, Mumbai and its branches at New Delhi, Kolkata and Chennai. It can also be downloaded from NSDL's website.

- NSDL Website** - The NSDL website hosts exhaustive and updated information for investors, companies and Participants. Details available on the website include list of securities available for demat, Participant locations and contact details, dates & venues of forthcoming IDMs, various search options, important circulars, Bye Laws & Business Rules of NSDL etc. The website also facilitates registration of grievance and displays list of companies with poor demat confirmation record.

Towards education of Business Partners etc.:

- PMLA Seminars** - Seminars on various aspects of Prevention of Money Laundering Act, 2002 (PMLA) were organized at Mumbai, Delhi, Kolkata and Chennai during March - April 2008 jointly by NSDL, CDSL, NSE and BSE in association with Financial Intelligence Unit - India (FIU) and Securities & Exchange Board of India (SEBI). These seminars had separate modules for Brokers & Participants and were attended by more than 800 representatives.
- Training programmes for Participants:** NSDL conducts NCFM (NSE's Certification in Financial Markets - NSDL-Depository Operations Module) oriented training programmes for Participants to facilitate them to appear for the NCFM examination. During November 2007 to October 2008, these programmes were organised in 16 cities/towns, which were attended by more than 650 representatives representing various Participants.

NSDL also conducted training programmes for compliance officers of Participants. Areas covered during the training programmes were compliance requirements, surveillance & inspection and internal audit. During November 2007 to October 2008, two such programmes were organised which were attended by 33 representatives from various Participants.

- Training programmes for business partners:** NSDL periodically conducts three-day training programmes for Participants and two-day training programmes for Issuers / R & T Agents. Details of such programmes conducted from November 2007 to October 2008 are as follows:

Other Initiatives:

- Central Recordkeeping Agency (CRA):** NSDL has recently set up a Central Recordkeeping Agency (CRA) on behalf of the Pension Fund Regulatory and Development Authority (PFRDA) for the New Pension System (NPS) in India. Under the NPS, each new government employee opens an account with CRA who is identified through unique Permanent Retirement Account Number (PRAN). In this system, deductions are made from employee's salary on monthly basis and an equal amount of contribution is made by the Government. The amount gets invested through PFRDA appointed Pension Fund Managers (PFMs). The accumulated amount is reflected in employee's Permanent Retirement Account while employee is working and shall use the accumulations at retirement to procure a pension for the rest of the life. Subscribers in this system would benefit in many ways like portability across jobs and locations, choices of Pension Funds and investment schemes, freedom to switch between service providers and nationwide access.
- Information Sharing and Collaboration Pact between NSDL and Central Securities Depositories of the world:** During last year, NSDL has signed MOUs with depositories in Russia, Japan and Europe. These MOUs aim at co-operation in securities clearing and settlement related matters, promote access to each other's experiences and explore opportunities for co-operation. NSDL shares the opportunities relating to training of staff with these organizations for the purpose of learning from their practices to foster the prosperity of depository system in India.
