Attention of Participants is invited to NSDL circular no. NSDL/POLICY/2025/0129 dated September 29, 2025 (ref: SEBI circular no. SEBI/HO/ITD-1/ITD_VIAP/P/CIR/2025/131 dated September 25, 2025), regarding Compliance Guidelines for Digital Accessibility Circular 'Rights of Persons with Disabilities Act, 2016 and rules made thereunder- mandatory compliance by all Regulated Entities' dated July 31, 2025. Further, NSDL Circular no. NSDL/POLICY/2026/0065 dated April 28, 2026 was issued regarding submission of Initial Accessibility Audit Report.

As prescribed in the above-mentioned SEBI circular, Participants are required to submit the "Final Accessibility Audit Report" for digital platforms to the Depository by **July 31, 2026**.

In this regard, all Participants are advised to submit the Final Accessibility Audit Report for digital platforms in the format prescribed by SEBI, as specified in the aforesaid SEBI circular, same is enclosed as **Annexure A**, through email at nsdl-bp-inspection@nsdl.com.

Please note that the Participants shall ensure that the Accessibility Auditor comprehensively covers all applicable digital platforms within the scope of the audit. This shall include websites, mobile applications, portals, and similar interfaces.

Further, the Participants should include the auditor's certification details (IAAP ID / Certificate Number) as well as their contact information, in the signed audit report.
