In this regard, a new field Darpan Id(ISO Tag-DrpanId) is introduced in the below mentioned file formats

1. BO Upload
2. Client master Export

Currently Darpan Id is captured under existing field Dummy_Field_3 with ISO tag Rsvd3. Participants are requested to discontinue capturing Darpan ID in dummy_field_3 and use aforementioned new field to capture Darpan ID from August 28, 2026 onwards.

Participants are requested to take note of above and make necessary changes in their Back-office system.
