Subject - DPM Plus enhanced - Facility for Clients to opt-in and opt-out of nomination online

Attention of Participants is invited to NSDL Circular No. NSDL/POLICY/2021/0078 dated July 26, 2021 informing SEBI Circular No. SEBI/HO/MIRSD/RTAMB/CIR/P/2021/601 dated July 23, 2021 regarding nomination for eligible trading and demat accounts. In this regard, NSDL is pleased to introduce an online facility for Clients to opt-in and opt-out of nomination including e-Sign of the nomination declaration form in an online mode. The feature will be released in the first week of February 2022. The salient features of the facility are as follows:

1. The existing demat account holders will have the ability to opt-in / opt-out of nomination in an online mode on NSDL web portal viz., <DPM Plus url>.
2. Clients will be able to eSign the opt-in / opt-out of nomination declaration form.
3. Participants of such Clients will be able to verify the declaration form with demat account and submit their confirmation/rejection, as the case may be.
4. Post submission of the confirmation by the Participant, the demat account details of the Clients will be updated in the NSDL Depository System with the requisite option as opted by the Clients.
