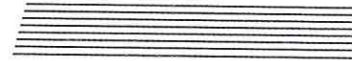

July 16, 2024 to SEBI under the SEBI (Settlement Proceedings) Regulations, 2018 for settlement of proceedings. In response to aforesaid consent application, an amount of Rs. 40,20,000/- proposed by the Internal Committee ('IC') of SEBI held on September 10, 2024 has been accepted by the Company. Further, the acceptance of the Revised Settlement Term and a Compliance Certificate listing out the compliance carried out/measures adopted by the Company has been sent to SEBI vide letter dated September 25, 2024. Further, payment of the said settlement amount had been made to SEBI on December 23, 2024, following which SEBI had passed the settlement order dated January 6, 2025 and disposed off the adjudication proceedings in the said matter. c. SEBI had undertaken an inspection of the processes of the Company relating to the securities kept in the pool account of the Company for the period from April 1, 2023 to May 31, 2023. Pursuant to the same, SEBI has, vide its Show Cause Notice dated June 19, 2024 had initiated Adjudication proceedings under the provisions of Section 15H of SEBI Act, 1992 on the Company. Accordingly, the Company had filed its response to the Show Cause Notice vide its letter dated July 24, 2024. Further, the Company had also filed a settlement application to SEBI under the SEBI (Settlement Proceedings) Regulations, 2018. In response to the aforesaid consent application, an amount of Rs. 80,46,000 /- was proposed by the Internal Committee ('IC') of SEBI at its meeting held on November 8, 2024 and the same was accepted by the Company. The settlement order was still awaited from SEBI.
